Ddydd Mercher, 13^{eg} Gorffennaf 2016, cymeradwyodd Cyngor Sir Caerfyrddin y cynnig canlynol:

Newid categori iaith Ysgol Gyfun Gymraeg Bro Myrddin o ysgol ddwyieithog (categori 2A) i ysgol cyfrwng Cymraeg (categori CC) o 1^{af} Medi 2016 ymlaen.

Ystyriodd y Cyngor y cynnig yn unol â gofynion Cod Trefniadaeth Ysgolion 2013 a nododd fod dau wrthwynebiad wedi dod i law ynghylch y cynnig yn ystod y cyfnod gwrthwynebu statudol.

Wrth ddod i benderfyniad ar y cynnig, ystyriodd y Cyngor y ffactorau canlynol fel y'u hamlinellwyd yn nogfen Cod Trefniadaeth Ysgolion 2013 fel a ganlyn:

Ansawdd a safonau mewn addysg

Barn Estyn oedd y byddai'r cynnig o leiaf yn cynnal y safonau addysgol presennol yn yr ysgol a bod y cynnig yn unol â Chynllun Strategol Cymraeg mewn Addysg Sir Gaerfyrddin i gynyddu'r ddarpariaeth addysg cyfrwng Cymraeg yn yr Awdurdod Lleol. Wrth gymeradwyo'r cynnig hwn, ystyriodd y Cyngor ganrannau llwyddiant yr ysgol sy'n dangos fod disgylion yn perfformio'r well wrth astudio pynciau trwy gyfrwng y Gymraeg yn hytrach na Saesneg. Yn ogystal, mae'r ffaith fod canlyniadau iaith Saesneg TGAU yn uwch na chanrannau lleol a chenedlaethol yn dangos nad oes angen pryderu. Yn ogystal, barn y Cyngor oedd bod cael grwpiau cyfrwng Cymraeg yn unig yn fwy manteisiol yn academiaidd gan y bydd disgylion yn gallu cael eu rhoi mewn grwpiau o'r un gallu. naturiol ar gyfer yr ysgol a bydd yn sicrhau bod yr ysgol yn ddigonol o ran darparu addysg cyfrwng Cymraeg sy'n ateb y gofynion cynyddol. Ni fydd dim newid i ddisgyblion presennol yr ysgol.

Notification of County Council Decision - **Change in language category for Ysgol Gyfun Gymraeg Bro Myrddin**

On Wednesday 13th of July 2016, Carmarthenshire County Council approved the proposal as follows:

To change the language category of Ysgol Gyfun Gymraeg Bro Myrddin from Bilingual (category 2A) to Welsh Medium (category WM) from 1st September 2016.

The Council considered the proposal in accordance with the requirements of the School Organisation Code 2013 and noted that two objections had been received in respect of the proposal during the statutory objection period.

In determining the proposal the Council took into account the following factors as outlined in the School Organisation Code 2013 as follows:

Quality and standards in education

It was Estyn's opinion that the proposal would at least maintain the current educational standards at the school and is in line with Carmarthenshire's Welsh in Education Strategic Plan to increase the provision of Welsh medium education in the local authority. In approving this proposal, the Council has considered the success percentages of the school which show that pupils perform better when they study subjects through the medium of Welsh rather than English. Also, the fact that English GCSE language results are higher than local and national percentages show that there is no need for concern. The Council also considered that having only Welsh medium groups is academically advantageous as pupils will be able to be placed in groups of the same ability. These groups would reflect the ability of pupils across the whole cohort rather than just across the teaching medium.

Need for places and the impact on accessibility of schools

In approving this proposal, the Council has considered the demand for Mathematics and Science education through the medium of Welsh and English. Over a period of 15 years, the percentage of

pupils who have chosen to follow the courses through the medium of English has gradually fallen whilst the percentage of pupils who have chosen to follow the courses through the medium of Welsh has increased. This will be a natural change for the school and ensures that the school is sufficient in providing Welsh medium education which meets the increasing demands. There will be no change for current pupils at the school.

Resourcing of education

The Council has considered that this proposal would save money in terms of staffing in the Science Department in particular. Offering courses through the medium of Welsh only would enable members of the Science Department to be released to assist with other aspects of the curriculum at no additional cost to the school.

Objections to the Proposal

Two objections were received.

The Council considered the objections received and agreed that the proposal moves the school naturally along the Welsh language continuum in accordance with Carmarthenshire's Welsh in Education Strategic Plan 2014-2017.

Referral of local authority decisions to the Welsh Ministers

Should any of the following bodies believe that an incorrect decision has been made by the local authority then under section 54 of the 2013 Act they may within 28 days refer the proposal to the Welsh Ministers for consideration:-

- Another local authority affected by the proposals;
- The appropriate religious body;
- The governing body of a voluntary or foundation school;
- A trust holding property on behalf of a voluntary or foundation school;
- A further education institution affected by the proposals.
